



Terms & Conditions

Acceptance of orders by BLUESKY MAST is conditioned upon Buyer's assent to these Terms and Conditions.

If any of these Terms and Conditions are not acceptable to Buyer, BLUESKY MAST must be notified at the time of initial order placement. Any change or waiver of BLUESKY MAST's standard Terms and Conditions must be supplied to Buyer in writing and will apply only to the specific transaction to which it is referenced.

The validity, construction, and enforcement of the purchase order between BLUESKY MAST and Buyer shall be governed by the laws of the State of Florida

Certifications

Certifications for material and finishes must be specified at the time of order.

RoHS compliance must be specified at the time of order.

Shipping

Shipping terms are FOB Largo, FL, added to invoice.

We ship via Buyers requirements

If products are damaged in transit, Buyer is responsible for filing insurance claim with freight carrier or with insurance companies. Buyer is still liable to BLUESKY MAST for invoiced charges.

Warranties and Returns

Our liability is limited to the cost of the part and in no cases shall we be liable for indirect, incidental or consequential damages.

If there is an issue with the part, we will rework it, remake it, or provide a credit at our discretion.

An RMA (Returned Goods Authorization) number will be issued, and this RMA number must be noted on the return package. Packages without an RMA number may be refused.

Returns after warranty require BLUESKY MAST approval.



BLUESKY MAST will be indemnified and held harmless for any and all claims or liabilities which may arise from any injuries or damages resulting from the owner's conduct including such actual, reasonable attorney's fees BLUESKY MAST may incur in defending such claims or liabilities.

Purchase Order Pull ins , Delays or Cancellations

The following lead times will be in effect and may be subject to change

Less than 5 systems – lead time 3-5 days

5 – 10 systems – lead time 5 -7 days

10-25 systems – lead time 14 days

Greater than 25 systems – lead time 30 days

Once a purchase order has been accepted and build begins any changes to delivery date (Buyer expedites, Buyer Delays and/or Cancellations) will be subject to a 20% fee for expedites and/or delays. Canceled orders for which work has begun will be subject to a 20% re-stocking fee.

Delivery Times

Quoted delivery times are an estimate at the time of quotation.

Price and Payment Terms

PRICE, TERMS OF PAYMENT, 1. BlueSky Mast's published prices, terms of payment, including discounts, and transportation terms in effect at DATE OF QUOTE of goods, shall apply unless (a) expressly provided otherwise in BlueSky Mast's price sheets in effect at DATE OF THE ACKNOWLEDGMENT, or (b) expressly provided otherwise in this Agreement.

BLUESKY MAST standard payment terms are net 30 days from the date of invoice. All Buyer accounts are subject to credit approval in order to receive our standard terms. Notwithstanding this policy, some orders are additionally subject to partial or complete prepayments depending upon the nature of the order and the Buyer's payment history.

Overdue Invoices

Past due invoices may incur a 2% per month interest charge.
